


Donlands Station Second Exit/Entrance and Easier Access Improvements – Overview Parking Considerations & Proposal

Donlands Station will become accessible

 New elevators, sliding doors, accessible fare-gates at main entrance on Donlands Avenue.

Elevators are under construction.



Donlands Station Elevator Site Plan



E1 – Street-level location of new elevator to access the street-to-concourse-to eastbound subway platform level.

E2 – Underground location of new elevator to access the concourse-to westbound platform subway level.

Future Secondary Entrance/Exit - 17/19 Dewhurst

- Enhances safety and customer convenience.
- Location recommended by a Local Working Group of neighbours and business representatives following extensive consultation in 2016-2017.



















Conceptual Staging – Phase 1A Second Exit/Entrance


Conceptual Staging – Phase 1B





New Street Parking Proposed on Dewhurst (east side)

- City must convert Dewhurst Blvd to one-way southbound from Fielding Ave to Danforth Ave to accommodate new, additional parking spots.
- Creates a minimum of 8 new permit spots on the east side of Dewhurst from Strathmore Blvd to Fielding Ave
- Laneway south of Strathmore remains accessible from Donlands Avenue or from southbound Dewhurst



Overnight Parking for street permit holders in zone 8A

Green P Lots - Langford and Woodycrest

- Overnight parking is permitted for permit holders from 10:00 p.m.- 8:00 a.m. in the Langford Ave lot (Lot 142)
- Overnight parking is permitted for permit holders from 8:00 p.m.- 8:00 a.m. in the Woodycrest lot (Lot 149)
- Total of 27 spots in the Langford Avenue lot
- Total of 35 spots in the Woodycrest Avenue lot
- First come first served in the Toronto Parking Authority lots



Nearby TPA/Green P Lots - Overnight Parking





Address: 12 Woodycrest Ave

Capacity: 35 Spaces

Hours for permit holders: 8pm-8am

Address: 31 Langford Ave

Capacity: 27 Spaces

Hours for permit holders: 10pm-8am



Next Steps

- Toronto & East York Community Council approval is required to convert Dewhurst to a one way street south of Fielding, to add on-street parking on the east side of the street.
- Community Council approval of City Transportation's report would keep the accessibility and safety related construction on schedule for completion within three years.
